### **Terms and Conditions**

This online programme is organised and hosted by the Faculty of Business Administration and International Office at TH Rosenheim - referred to as **organising units**. With their application and participation, the students - referred to as **participants** - agree to the following regulations.

#### **Requirements for participation**

Participants need to provide a current proof of studies at the time of their application for the programme. Advanced English skills (B2 CEFR) are required to take part in the programme. Cf. *Common European Framework of Reference for Languages:* <u>The CEFR Levels (coe.int)</u>

#### Application and Registration as Feewaivers

Participants need to apply until May 31, 2021 by sending a complete application by e-mail. Dates and deadlines communicated on the website and advised in writing are binding. The application itself does not entitle the participant to a place on the programme. Only completed applications will be further processed and registered. For feewaivers, the participation in the Online Summer School programme is free of charge. After registration, participants will receive further information regarding the course details prior to the start of the programme.

#### **Data processing and Communication**

The applicant's data will be reviewed by the respective organising units and data will be passed on and processed by the organisers for the purpose of the application and participation. Further information regarding the acceptance or rejection of applications will be communicated through the e-mail address provided in the application form. With their application, participants agree to the privacy statements of the organising units and the terms of service of third-party online services.

#### Cancellation policy / Refund policy

The organising units reserve the right to cancel the programme in the event of unforeseen circumstances. In reasonable cases, participants may also cancel their participation. Participants agree to inform the organizers as soon as possible about their cancellation by e-mail.

#### **Credit Validation**

If accepted to the programme, credit validation and certificate will be provided based on attendance of mandatory sessions and successful examination of the programme. For the recognition of the rewarded credits at their home university, participants will consult their academic advisor to receive credit transfer approval before applying.
